Artists are invited to submit artwork for consideration to be included in the event's collection. All artwork will be reviewed and selected by Hickok Cole and WPA leadership. Hickok Cole sponsors all event expenses, allowing participating artists—including friends and family—to receive 50% of their sale price, with the other 50% donated to WPA.

All artists are encouraged to arrive between 5:45 PM and 6:00 PM, prior to the start of the event. This is a great opportunity to scope out where your work is located for the show, and prepare to connect with potential buyers.

Artists will be provided with a special name tag that differentiates them from guests. This visual identification allows Hickok Cole staff and potential buyers to identify you as an artist in case they have questions or want to discuss your work. Most importantly, it provides an opportunity for you to make a deeper connection with your buyer, rather than just a one-time sale.

Hickok Cole is located in NoMa at the corner of 3rd and N Streets NE. The closest Metro station is NoMa-Gallaudet U (Red), and there are a variety of WMATA bus stops located nearby.

All submissions are reviewed by Hickok Cole senior leaders and WPA staff. Artists will be notified on or before **Friday, August 30, 2024** whether or not their work has been accepted. If your work has been accepted for inclusion in the show, you will be sent an email containing a mandatory WPA Artist Contract to sign and return.

PLEASE NOTE: All pieces must be for sale, and arrive well-framed and professionally presented prior to installation to be included in the show. Pieces must also be photographed for inclusion in our virtual gallery as sales transactions occur online.. Decisions to exclude pieces that do not meet this criteria are made at the discretion of the curator(s).

- Work that is not received by **September 27, 2024** risks not being included in the show.
- All 2D and 3D artwork must be ready for installation and exhibition and equipped with D-Rings and/or wire—no sawtooth hangers (see submission form).
- All 3D artwork must be clearly marked with installation and display instructions.
- Include the artist's name, name of the piece, and price attached to the back for identification purposes.
- If you have multiple pieces, please provide info "1 of 2," "1 of 3," etc. on the back of each piece.
- All artwork must be packaged appropriately.
- All other mediums, including but not limited to, media and site-specific installations will be arranged on a case-by-case basis between the artist and WPA.
